The Fledge and Michigan Mosaic Energy Cooperative Team would like to introduce you to our project: HIRED! Hyper Inclusive Regenerative Energy DAO. We believe it meets and exceeds the specifications for your Inclusive Energy Innovation Prize.

The Fledge is a radically inclusive community hub on a mission to eliminate poverty through diverse opportunities, workforce development, skilled training, and free programming. We have created our own crypto currency with real monetary value and a system to keep the money and benefit in the community that is investing into the locally developed DAO. This allows the people to spend their investments in ways that directly benefit themselves and their environment, creating a way to gain wealth where there was none. Community resources bought by the DAO (individual investments) are provided directly to the investors. These investors are the community members living in poverty (25% of Lansing for over 40 years) and those living below the ALICE Threshold (42% of Lansing). This program will decrease the 50% rental property housing statistic in Lansing and increase the amount of property holders, giving people a chance to build equity and generational wealth.
