## Summary of proposed work:

Farmers Conservation Alliance (FCA) is a 501(c)3 non-profit organization that works with irrigation districts, ditch companies, and agricultural producers (collectively referred to as irrigation communities) across the West to modernize irrigation infrastructure in a manner that provides agricultural, environmental, and community benefits. The proposed project will assess energy generation and conservation opportunities in at least three of these irrigation communities, a critical first step in moving from concepts to shovel-ready projects. These assessments provide the foundation for designing, funding, and permitting on-the-ground projects. When complete, these projects can increase rural energy resiliency, reduce operations costs for agricultural water providers and producers, and provide revenue to accelerate infrastructure modernization efforts at scale. The proposed activities will build on existing infrastructure modernization efforts and provide a replicable model for renewable energy development in irrigation communities across the West.
