Background: DOE, OCED, and ERA

DOE is pursuing efforts to enable an **inclusive and just entrepreneurial innovation ecosystem** in climate and energy technologies

Within DOE, the Office of Clean Energy Demonstrations (OCED)'s mission is to deliver clean energy demonstration projects at scale in partnership with the private sector to accelerate deployment, market adoption, and the equitable transition to a decarbonized energy system.

At OCED, the Energy Improvements in Rural or Remote Areas (ERA) Program is designed to provide financial assistance to improve, in **rural or remote areas of the United States**, the resilience, safety, reliability, and availability of energy and environmental protection from adverse impacts of energy generation.

Through workshops and community input, ERA has found that two of the biggest barriers to improving energy systems in rural or remote areas are developing the necessary partnerships and securing financing.



Timeline



I have a tax related question....

We cannot answer tax questions. Some of the power connectors may be able to answer these questions, but we recommend asking a tax professional.

What are the reporting requirements for the Prize award?

Easy, none. Prizes do not require additional reporting. Prize competitors should refer to the official rules document for eligibility, however.

Do you anticipate another Phase One round in FY24? We cannot speak to the potential for any future funding opportunities.

In general however, the Infrastructure Investment and Jobs Act, commonly referred to as the Bipartisan Infrastructure Law (BIL), directs DOE's Office of Clean Energy Demonstrations (OCED) to invest \$1 billion in energy improvements in rural or remote areas. OCED's Energy Improvements in Rural or Remote Areas (ERA) Program will provide financial investment, technical assistance, and other resources to advance clean energy demonstrations and energy solutions that are replicable and scalable. This program has \$200,000,000 appropriated annually for fiscal years 2022 through 2026.
