# Benefits of Partnering in Phase II

---

- Partnering in Phase II is a way to strengthen the submission for Phase II by providing a more comprehensive solution
- Partnering is not a requirement, however, it is encouraged due to the disparate skillsets needed to address the battery logistics issue.

# Partnerships Guidelines

---

- Each team can only lead one submission
  - Team members can participate in multiple submissions.
- Each Phase II winning submission will receive one check to distribute among partners accordingly
- **The Prize Administrator will not be involved in inter-partnership disputes.**

---

- **If two winning teams from Phase I partner, will they submit their proposal jointly or separately?**
  - Answer: Each winning team can each lead one submission to Phase II, but you can partner with other teams on additional submissions.
  - Teams cannot submit identical submissions.

# Questions

---

- **What is the incentive to partner in Phase II?**
  - Answer: Partnering is a way to strengthen your submission for Phase II and provide a more comprehensive solution to the battery logistics issue.
  - Partnering is not a requirement, as stated in the rules. However, partnering is encouraged due to the disparate skillsets needed to address this issue.

# Questions

---

- **Can we partner with teams that were not winners of Phase I?**
  - Answer: Yes. Groups that did not win in Phase I can partner with winning teams to submit a concept for Phase II. In order to be eligible for Phase II, a submission must be led by a Phase I winning team.
  - Each Phase I winning team can only lead one Phase II submission.


# Questions

---

- **Are we required to have a business/profit sharing arrangement with partners?**
  - Answer: It is up to your team to determine the agreement between your partnerships.
  - Each Phase II winning submission will receive one check to distribute among partners accordingly.
  - The Prize Administrator will not be involved in inter-partnership disputes.

# Voucher Introduction

- **Winners of Phase II will receive \$100,000 in non-cash vouchers for use in Phase III**
  - Vouchers will apply only to the American-Made Network of Voucher Service Providers (VSPs)
  - These VSPs are approved organizations and facilities (such as national laboratories) who can provide services in exchange for voucher funds
